Appendix for LINZ to General Conditions

for container transports in 2025

1. <u>The prices include:</u>

1.1. The CY prices (up to terminal only or vice versa) include 1x handling (terminal – wagon or vice versa) at CCT Linz. The terminal – truck (or vice versa) handling is invoiced by CCT Linz. The all-in prices (including truck delivery) include 2x handling at CCT Linz.

2. <u>Further regulations, surcharges and additional services:</u>

- 2.1. Surcharge for dangerous goods (incl. under limited quantity, limited quantity and uncleaned empty containers) in addition to transport tariff price:
 - Class I and tank containers with dangerous goods of class II VI a VIII IX will be calculated individually.
 - Dangerous goods of class II VI and VIII IX packed in pieces in box containers will be calculated individually.
 - Class VII.....excluded from transport
 - If exceptions or special permits etc. apply, any diversion from applicable laws is to be noted and a copy of any relevant document to be included with the transport.
- 2.2. Storage of containers in import as well as export direction at CCT Linz

- Empty containers: in total 3 days free	
from 4 th day	EUR 2,00 / TEU / day
- Full containers: in total 3 days free	
from 4 th day till 7 th day	EUR 2,80 / TEU / day
from 8 th day	
Storage of dangerous goods on CCT Linz is exclude	

2.3. Weighing of containers

- Weighing in accordance with SOLAS guidelines including weighing document (advance notification required)
 - Weighing after arrival at the terminal without prior notification......EUR 107,40
- 2.4. Transports by truck over 29t gross (including container tare) are possible only after previous agreement. Surcharge for truck transports over 29t gross will be calculated individually.
- 2.5. The costs of vain rides are calculated individually.
- 2.6. Prices for deliveries to more places within one municipality will be calculated individually.
- 2.7. In case of CY transport (up to terminal only or vice versa), every additional cost or surcharge such as storage or VGM, will be invoiced by CCT Linz. In case of all in transport (including truck delivery), every additional cost or surcharge such as storage or VGM, will be invoiced by METRANS. Any additional costs, surcharges or fees incurred at CCT Linz will only be invoiced once a month after receipt of the monthly statement from CCT Linz to METRANS.

- 2.9. For purpose of this Appendix of General Conditions and also METRANS tariffs, weight is understood as the total weight of the container (weight of the carried goods and the container's tare)
