1. Further regulations, surcharges and additional services:

1.1. Fee for dangerous goods (incl. under limited and limited quantity and uncleaned empty containers) to combined transport tariff price:

- 1.1.1 Class 1 and tank-containers with dangerous goods of class 2 – 6 and 8 -9.....**EUR 75,-**
- 1.1.2 Dangerous goods of class 2 – 6 and 8 – 9 packed in pieces in box containers:..**EUR 35,-**
- 1.1.3 Class 4.1, 5.2 self-reactive + with controlled temperature, 6.2, 7.....**excluded from transport**
...(appendix/addition to point 3.24. of General Conditions 2026)

Handling and storage conditions for ADR/RID transports at Metrans Budapest terminal

- 1.1.4 Storage of class 2.2, 3, 4.1, 4.2, 4.3, 5.1, 5.2, 6.1, 8, 9 (II., III PG) packed in ISO **dry or tank** containers.....7 days (168h) after the arrival to the container terminal the storage is permitted. After this period the container has to be moved to the special safety place within the terminal for extra charge **EUR 50,-THC + 1x EUR 150,-**
- 1.1.5 In case the container would not be picked up from the terminal within the second 168h (stored at the safety place), we reserve the right to move out the container from the terminal (even with return by rail to the seaport) at the expense of the customer.
- 1.1.6 Possibility and conditions for transports of the following dangerous goods classes have to be discussed in advance:

1, 2.1, 2.3, 3, 4.1, 4.2, 4.3, 5.1, 5.2, 6.1, 8, 9 (I. PG), Class 6.1 with any subsidiary risk, Class 4.1 polymerizing substances and solid desensitized explosives.

If the transport will be accepted, for these classes the maximum allowed storage time is **24 hours** after the first GATE IN to the container terminal! The container has to be picked up from the terminal within **24 hours!!!**

In case it wouldn't be, the following extra charges will be counted:

- 1st day (after first 24h) EUR 200,-
- 2nd day (after second 24h) EUR 200,-
- 3rd day (after third 24h) EUR 500,-

Forbidden classification codes: D, DT (solid desensitized explosives), SR1, SR2 (self-reactive substances with / without temperature control), PM1, PM2 (polymerizing substances with / without temperature control).

In the attached excel sheet you can find the overview of all above mentioned dangerous good classes and their classifications to handling categories.

Please note, any kind of DG container (full or empty unclean containers) would be accepted to the terminal only in case, that by the arrival with truck, all the related documents (DGD, MSDS in case of deep sea transport, or document from the previous transport in case of short sea transport – like CMR, packing list - where the exact material description identification is possible – would be available by the truck driver, or previously sent to our customer service.

to General conditions for container transports in 2026

1. Further regulations, surcharges and additional services:

1.1. **By the truck delivery in Romania (via AFLUENT Arad terminal)** there is free time for loading / unloading, eventual custom procedures and all other stops/activities **8 hours** since delivery of the container to the first delivery place (loading / unloading place or custom office). There's not counted in this time the time of driving between particular stops. By exceeding this free time there will be charged waiting time **EUR 30,-/ctr. for each next commenced hour** till the end of all activities / stops; the waiting time surcharge is counted **EUR 125,-/calendar day maximally**.

1.2. **Storage** of dangerous goods in import as well as export direction at AFLUENT Arad terminal in Romania:

Storage of class **2.2, 3, 4.2, 4.3, 5.1, 5.2, 8, 9** packed in ISO **dry or tank** containers:

1 day (24h).....	free
between day 2 -day 5 (max.120 h)	EUR 25,-/day/TEU
between day 6 – day 14 (max.168 h)	EUR 40,-/day/TEU

1.2.1. Storage of class **2.2, 3, 4.2, 4.3, 5.1, 5.2, 8, 9** packed in ISO **dry or tank** container.....5 days (120h) after the arrival to the container terminal the storage is permitted. After this period the container has to be moved to the special safety place within the terminal for extra charge
..... **EUR 50,-THC + 1x EUR 150,-**

1.2.2. In case the container would not be picked up from the terminal within the second 168h (stored at the safety place), we reserve the right to move out the container from the terminal (even with return by rail to the seaport) at the expense of the customer.

1.2.3. Possibility and conditions for transports of the following dangerous goods classes have to be discussed in advance: **2.1, 2.3, 6.1**. If the transport will be accepted, for these classes the maximum allowed storage time is **24 hours** after the first GATE IN to the container terminal! The container has to be picked up from the terminal within **24 hours!!!**

In case it wouldn't be, the following extra charges will be counted:

1 st day (after first 24h)	EUR 200,-/box
2 nd day (after second 24h)	EUR 200,-/box
3 rd day (after third 24h)	EUR 500,-/box

All other classes not mentioned are **forbbiden**.

1.3. Extra charge for special SUMAL DOCUMENTATION (requested for "wood" transport)... **EUR 5,-/TEU**

to General conditions for container transports in 2026

1. Further regulations, surcharges and additional services:

1.1. **By the truck delivery in Romania (via Yusen Bucharest terminal)** there is free time for loading / unloading, eventual custom procedures and all other stops/activities **4 hours** since delivery of the container to the first delivery place (loading / unloading place or custom office). There's not counted in this time the time of driving between particular stops. By exceeding this free time there will be charged waiting time **EUR 20,-/ctr. for each next commenced hour** till the end of all activities / stops; the waiting time surcharge is counted **EUR 150,-/calendar day maximally**. Once the waiting time exceeds midnight, an additional **EUR 150,-** will automatically be charged. Any additional fees charged at customs place or loading/unloading place (e.g. parking) will be reimbursed based on actual costs.

1.4. **Storage of dangerous goods** in import as well as export direction:

Storage of class **2.2, 3, 4.2, 4.3, 5.1, 5.2, 8, 9** packed in ISO **dry or tank** containers:

1 day (24h)	free
between day 2 -day 5 (max.120 h).....	EUR 25,-/day/TEU
between day 6 – day 14 (max.168 h)	EUR 40,-/day/TEU

1.4.1. Storage of class **2.2, 3, 4.2, 4.3, 5.1, 5.2, 8, 9** packed in ISO **dry or tank** container.....5 days (120h) after the arrival to the container terminal the storage is permitted. After this period the container has to be moved to the special safety place within the terminal for extra charge
.....**EUR 50,-THC + 1x EUR 150,-**

1.4.2. In case the container would not be picked up from the terminal within the second 168h (stored at the safety place), we reserve the right to move out the container from the terminal (even with return by rail to the seaport) at the expense of the customer.

- 1.4.3. Possibility and conditions for transports of the following dangerous goods classes have to be discussed in advance: **2.1, 2.3, 6.1**. If the transport will be accepted, for these classes the maximum allowed storage time is **24 hours** after the first GATE IN to the container terminal! The container has to be picked up from the terminal within **24 hours!!!**

In case it wouldn't be, the following extra charges will be counted:

1 st day (after first 24h).....	EUR 200,-/box
2 nd day (after second 24h)	EUR 200,-/box
3 rd day (after third 24h)	EUR 500,-/box

All other classes not mentioned are **forbbiden**.

- 1.5. Extra charge for special **SUMAL DOCUMENTATION** (requested for "wood" transport)... **EUR 5,-/TEU**

- 1.6. **Repairs** of containers:

- 1.6.1. Smal repairs, subject to confirmation and will be settled case by case against expenses report.
1.6.2. No repairs to floor, corner or main structure of container.

- 1.7. **UIT (Unique code for transport identification)** - is the customer's responsibility

- 1.8. **Customs formalities performed in Constanta port (CSCT):**

- 1.8.1. T1 in Constanta for **final clearance in Romania**:
1.8.1.1. Up to EUR 100.000 cargo valueEUR 55,-/box
1.8.1.2. For cargo value between EUR 100.000 and EUR 200.000EUR 85,-/box
1.8.2. T1 in Constanta for **final clearance in EU countries**:
1.8.2.1. Up to EUR 100.000 cargo valueEUR 100,-/box
1.8.2.2. For cargo value between EUR 100.000 and EUR 200.000EUR 150,-/box
