Appendix for METRANS service via Istanbul

to General Conditions for container transports in 2026

1. General transport conditions:

- 1.1. The Ordering Party is obliged to announce any special requirements or permits if they are necessary on the requested transport line.
- 1.2. For all transports from/to Turkey, a special statement requested by the customs authorities needs to be completed. The declaration must be presented at the point of entry/exit from/to the EU. If this statement is not provided by the Ordering Party, the cargo cannot enter/leave the territory of the EU.
- 1.3. The unloaded container must be returned to the terminal in clean and undamaged condition. In case any damage occurs or the container is not cleaned, METRANS reserves the right to charge the costs of repair, respectively of cleaning.
- 1.4. If issuance of the T1/T2 document is arranged by METRANS, information such as the HS code, colli, weight and the exact value of the goods has to be indicated for each commodity separately in the transport order.
- 1.5. In case METRANS containers are used for the transport and the trucking in Turkey is done by the Ordering Party, METRANS reserves the right to determine the depot which the container must be returned to or picked up from.
- 1.6. If the trucking part in Turkey is ensured by METRANS, the **free time for loading/unloading** is **12 hours**, after which there is a waiting fee of **EUR 46.00** for every 12 hours. After 3 days, for every 12 hours additional **EUR 75.00** will be applied.
- 1.7. In case of empty container repositioning between the depots in Turkey, a surcharge in the amount of **EUR 200.00/container** needs to be applied.
- 1.8. The container needs to be delivered to Halkali by the closing of the train, the closing is always 12:00 a.m. on the day of the departure. Information about the planned departures are provided by our Customer Servoce Department. In case of cancellation the rail transport to / from the port less than 48 hours before the scheduled departure, METRANS may be entitled to charge EUR 800.00/BOX. The Principal will also be charged for any costs incurred in connection with the ordered transport and/or its cancellation.

2. Tariff surcharges for terminal services at Halkali terminal in Turkey:

2.1. Additional charges

2.1.1. Registration - Kapikule	EUR 5.00/container
2.1.2. Registration - Halkali	EUR 25.00/container
2.1.3. Weighbridge fee	EUR 8.00/container

- 2.4. Fee for container rental in total 7 days free, from 7th day...... EUR 10.00/container and day
- 2.6. Additional surcharge for truck transport of dangerous goods in Turkey ensured by METRANS is **EUR** 123.00/container.
 - Dangerous goods can be accepted for transport only after previous agreement.
- 2.7. Truck delivery free time and waiting time
 - In case of truck delivery in Czech Republic, Slovakia and Poland via METRANS terminals, in Hungary (via METRANS Budapest terminal), the free time for loading / unloading, custom clearance and other stops/activities 3 hours counted from the first positioning of the container at the place (loading / unloading place, custom office or to other stops/activities). This time does not include the driving time between the individual stops. After exceeding the free time, a surcharge of EUR 30.00/container will be charged for each commenced hour until the end of all activities; the maximum amount of waiting surcharge is EUR 300.00/calendar day.
 - In case of truck delivery in Austria via METRANS Krems terminal, the free time for loading / unloading, customs clearance and other stops/activities in case of an "all in" service to/from ports of Hamburg, Bremerhaven, Wilhelmshaven, Koper, Rotterdam, Duisburg, Gdansk is 4 hours from the first arrival of the container at the loading/unloading point or customs office, in all other cases the free time for loading/unloading/customs procedure is 2 hours from the arrival of the container at the first delivery point. This time does not include the driving time between stopping points. When exceeding the free time, EUR 30.00/container will be charged for waiting for each commenced half an hour until the end of the activities is completed.
 - <u>In case of truck</u> delivery in Austria via CTS Salzburg terminal, the free time for loading/unloading and customs clearance is 2 hours. If the free time is exceeded, a waiting fee of EUR 30.00/container will be charged for every commenced 30 minutes.
 - For truck delivery in Austria via Linz terminal, the free time for loading/unloading and customs clearance is 2 hours. When exceeding the free time, EUR 65.00/container for each commenced hour will be charged until the activities are completed.
 - The consignee or consignor is obliged to confirm to the haulier the completion of loading or unloading on a separate form or electronic device available at the driver.

• If the truck crosses the Schengen Area border during delivery and if this results in a delay of the delivery by a maximum of 2 hours compared to the originally agreed time, this delivery is considered to be on time. The same applies if there are border restrictions within the Schengen Area.

3. Returning of empty METRANS 45'HCPW equipment:

3.1. In case of using METRANS containers, it is necessary to add the empty repositioning costs before/after the transport to the tariff transport prices based on the table below, as the main depots for METRANS equipment are METRANS Dunajska Streda, METRANS Praha and METRANS Ceska Trebova. In our pices below no handlings are included at the seaport.
